

Brief Profile of Mr Rushad Abadan

Mr Rushad Abadan is Group General Counsel of Standard Life Aberdeen plc leading its Legal and Secretariat functions worldwide. Before joining Standard Life, Rushad was Deputy General Counsel at RBS Group. Earlier in his career, Rushad had stints at Dundas & Wilson (now CMS Cameron McKenna) in the UK and DSK Legal (erstwhile Andersen Legal) in India, both focusing on M&A and private equity work. He also worked at Arthur Andersen in its Indian tax practice. Rushad has a range of experience covering public/ private M&A, capital markets, regulatory, and corporate governance matters in various international jurisdictions as well as extensive experience leading in-house teams. He is qualified as a solicitor in India, and England and Wales.

Brief Profile of Mr James Aird

Mr James Aird has been the Chief Executive of Ignis Investment Services, since its acquisition by Standard Life Investments, where he is responsible for the day to day management of the business. In addition, James is Head of Strategic Development for Standard Life Aberdeen plc (formerly Standard Life plc) where he focuses on developing new international business, joint ventures and mergers and acquisitions and has responsibility for corporate finance. He joined Standard Life Aberdeen plc in 1997 and has held a number of senior roles within Standard Life Aberdeen plc including as Chief Executive of Standard Life Investments mutual fund business and as Director of Standard Life Investments (Asia) in Hong Kong.
