IMPORTANT

The transfer of a policy, whether wholly or in part, in consideration of a loan advanced by the transferee to the policyholder, shall not cancel the nomination but shall affect the rights of the Nominee only to the extent of the interest of the Transferee, as the case may be, in the policy. The nomination, which has been automatically cancelled consequent upon the transfer shall stand automatically revived when the policy is reassigned by the Assignee or retransferred by the transferee in favour of the policyholder on repayment of loan other than on a security of policy to HDFC Life.
- For cases where the assignment is in favour of an individual or Financial institution apart from our channel partners, then the Assignor must get the signature of the Authorised Signatory on the company seal.

- As per section 194DA of the Income Income-tax Act, 1961, tax will be deducted at source from the payments made to residents of any sum under a life insurance policy including the sum allocated by way of bonus, other than the amount exempt u/s 10(10D) of the Income Income-tax Act, 1961, at the rate as applicable subject to the conditions and limits specified therein.
- Assignor will not have the right to execute any policy alteration or processing without the written consent of the Assignee except as otherwise provided under No Objection For Servicing Transactions.
- Tax laws are subject to change.
- Nominee's address will be considered to be the same as the Policyholder's address.
- Reassignment of your policy shall be made by a separate instrument. Confirmation provided herein by Assignor and Assignee shall be considered as a consent to make the reassignment under the policy in accordance to the underwriting guidelines of HDFC Life.
- You agree and confirm that by making this application for Reassignment, all previous instructions for assignments received from you and not processed by the Company shall be null and void.
- Upon processing of your request for Reassignment, we shall intimate you and the Assignee about the same. You agree and confirm that upon receipt of such communication from us, you shall submit the policy document with the assignee's documents.
- Once you have reassigned, all the rights are transferred to the new Assignee. For all future assignment/reassignment within the policy, please submit all required documents as per the Company's Terms and Conditions.
